Subject: Business Update at the end of Q2 FY2025-26

With reference to the subject cited above, we wish to inform the Business update of the Company for the quarter and half year ended September, 2025 subject to audit.

- During Q2 FY2025-26, our company achieved a turnover of approximately **Rs. 444 crores**, representing a growth of **28%** compared to Rs. 347 crores in Q2 FY2024-25. For the H1 of FY2025-26, our turnover reached **Rs. 823 crores**, marking a significant rise of **34%** from Rs. 615 crores in H1 FY2024-25.
- During the quarter, the following 5 new stores were opened

- Our company is planning to expand its store presence with 10 new openings as follows.
 - Under the Kanchipuram Varamahalakshmi Silks format, we are planning to launch 6 new stores - 3 in Tamil Nadu, 2 in Karnataka, and 1 in Telangana. Additionally,
 - under the Valli Silks format, we are planning to launch 4 new stores, with 2 each in Andhra Pradesh and Telangana.
